Foreword

We extend our thanks to the North Carolina Central University School of Law alumni who have made the directory program a success by sending in their personal information, voluntary contributions, and information about “lost” alumni. Your participation and support have made this book possible.

The directory is divided into four sections. The primary listing is alphabetical, followed by class year, specialty, and geographical cross-references.

In the alphabetical section, each graduate’s name is followed by graduation year, business information and home address and phone number. When both professional information and home address are listed, the home address follows the business information, separated by a semicolon. When applicable, the graduate’s practice specialty is listed in parentheses following the class year.

Throughout the directory married women are listed by their current name, with their maiden name in parentheses. Maiden names are also alphabetized in the first section for easy cross-referencing.

In the class year cross-reference, alumni are listed alphabetically within their graduation year.

The third section lists the practice specialty, with alumni listed alphabetically within their specialty.

In the final section, the geographical cross-reference, alumni are listed by city and state, followed by foreign nations.

“Lost” alumni for whom we do not have a current address are listed in the alphabetical and class year sections only.
