The Weekly will be available in a more timely fashion, and

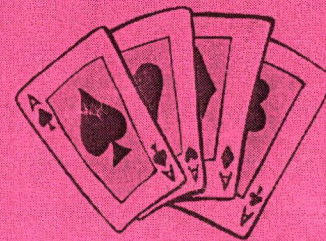
students will be able to access *The Weekly* from their computer at any time.

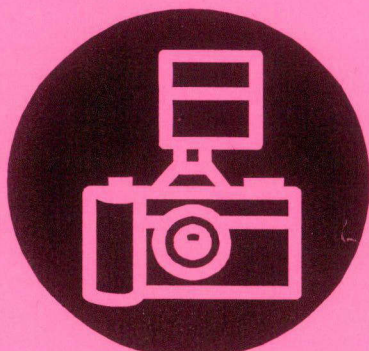
