IMPORTANT NOTICE FOR ALL STUDENTS:

What follows is a statement which is the result of a report submitted at the last NCCU Law School Faculty Meeting by the Law School Relations Committee. The statement is meant to address various concerns.

Lawyers are expected to adhere to the highest standards of professional behavior. The School of Law expects its students to adhere to high standards of behavior during their legal education and to avoid even the appearance of impropriety. Because law school is a student's first step toward be-

coming a member of the bar, the Student Code of Professional Responsibility expressly prohibits unprofessional conduct.

Prohibited conduct includes arriving late for class, leaving class without the professor's advance permission, talking or whispering to fel-



low students or using cell phones during class, eating or drinking (except in approved containers) in Classrooms 100, 102 and the Moot Courtroom, talking loudly in the Law School lobby, or in the hallways while class is in session, violating rules or circulation policies of the Law Library, and speaking disrespectfully to faculty, administrators, staff or fellow students. Persistent or flagrant instances of unprofessional conduct will be reported to the Law School Academic Disciplinary Committee and may result in suspension or expulsion.
