The Northwestern Center on Wrongful Convictions

played a major role in identifying a number of innocent Illinois death row inmates, leading to former Governor George Ryan's imposition of a moratorium on executions in Illinois in January 2000, and to a blanket commutation to all of Illinois' death row in January 2003.
